## **Teton Conservation District Noxious Weed Cost-Share Program 2011**

The Teton Conservation District provides noxious weed information and cost-share assistance to private landowners to help control noxious weeds in Teton County, WY. TCD will reimburse participants **up to 25%** of the cost of treating noxious weeds (*excluding the cost of herbicides*) on their property. We can cost-share on weed treatment costs that add **up to \$150/acre** on your property (any additional cost will be cut off from reimbursement). TCD and Teton County Weed & Pest District cooperatively provide assistance for landowners in the implementation of a noxious weed treatment plan on their property.

### **Important Dates:**

- Applications will be accepted from May 3, 2011 through August 17, 2011
- Completed reimbursement forms must be received by TCD by October 19, 2011

### **Program Requirements:**

- Applicants agree to an initial consultation that will be done by TCWP and TCD. During this consultation, TCD or TCWP will map the location of noxious weeds on the property. The applicant is responsible for treating noxious weeds according to the recommendations given at the time of the initial consultation and stated in the property's treatment plan
- Only the treatment of weeds designated as "noxious" by Teton County, WY will be eligible for cost-share (see list of approved species attached)
- All Applicants **MUST** submit proper documentation once their treatment is complete (Must be turned in no later than October 19, 2011)
  - o Must turn in a Request for Reimbursement form, any invoices, work orders, and/or documentation of time landowner spends treating their weeds
  - o There are two different forms for reimbursement, one for work done by commercial applicators, and one for work done by a landowner. You may need to fill out one, or both of these forms depending on who treated weeds on the property
- All Applicants will receive a follow-up visit by TCD or TCWP after treatment is complete and paperwork is turned in. Make sure to turn in your completed paperwork as soon as possible to ensure quick reimbursement.

### **Items Eligible for Cost-share Funds:**

- Hiring a commercial applicator (Applicators must have a Commercial Applicator's License)
  - o Businesses charge various rates for the different services they provide, we can only reimburse up to a total of \$150/acre on your property.
- Reimbursement for landowner's time spent treating weeds on their property
  - o Landowners will be compensated for hours spent treating weeds at a pre-determined rate, see request for reimbursement for further information on hourly compensation rates.

### **Miscellaneous Items:**

- Applicant agrees to give permission for TCD to release maps, Weed Management Plans, and inspection forms to their commercial applicators (if they have one). This is done to improve communication with and performance by the applicator where applicable.

## **Teton Conservation District's Noxious Weed Cost-Share Program**

This program was designed to increase the capacity and effectiveness of Teton County, Wyoming, landowners in controlling noxious weeds. This is accomplished through a cooperative partnership between the Teton Conservation District, Teton County Weed & Pest district and landowners. It provides both cost-sharing and technical assistance to program participants.

Reimbursement of up to **25% (of up to \$150/acre)** of noxious weed control costs are available through this program provided they implement an approved noxious weed control plan, submit proper cost documentation, and agree to a post treatment follow-up review.

**Applications** will be accepted from **May 3<sup>d</sup> through August 17<sup>th</sup>, 2011**. Request for Reimbursement forms with proper documentation are due to Teton Conservation District by **October 19, 2011**.
